The nonjudicial foreclosure process is used most commonly in our state. Nonjudicial foreclosure is the most common type of foreclosure in California.

The California foreclosure process can last up to 200 days or longer. Day 1 is when a payment is missed; your loan is officially in default around day 90. After 180 days, you'll receive a notice of trustee sale. About 20 days later, your bank can then set the auction.

A deficiency judgment is not allowed following a power of sale foreclosure in California. Because residential foreclosures are usually nonjudicial, this means that most Californians going through foreclosure don't have to worry about being on the hook for a deficiency judgment.

If the foreclosure was nonjudicial—as most residential foreclosures in California are—you can't redeem the home after a foreclosure sale. Judicial foreclosures. If the foreclosure was judicial, you can redeem your home within three months or one year, or not at all, depending on the circumstances.
