### Second Circuit rules against Chevron in Ecuador case ...

This is an important case because the Second Circuit overturned the Board of Immigration Appeals’ precedent decisions in *Matter of Blake*, 23 I. & N. Dec. 722 (BIA 2005), and *Matter of Brieva*, 23 I. & N. Dec. 766 (BIA 2005). The Second Circuit was the first court to reject the Board’s decisions in *Blake* and *Brieva*.
