### Guidance How to complete your ethics self-assessment

Ethics review by a Research Ethics Committee (REC) is typically required when (sensitive) personal data are being collected. The role of a REC is to protect the safety, rights, and well-being of research participants and to promote ethically sound research.

### Ethical review process - CESSDA TRAINING

There can be a potential conflict between abiding by data protection legislation and ethical guidelines, whilst at the same time fulfilling funder's and individual's requirements to make research results available. Ethics committees may believe that any personal or sensitive data should remain confidential.

### **Data protection and research ethics — University of Leicester**

Prior to Health Research Regulations, there was no mechanism in Irish law to address a situation where consent can not be obtained from a data subject, for health research. Previously some Research Ethics Committees (RECs) may have granted consent waivers. However, those waivers had no legal standing.

medical research has approval from a research ethics committee (as defined in the new Data Protection Act) if it involves processing data in order to do or decide something with respect to an individual person,

### **Safeguards - Health Research Authority**

Data Protection Officers are responsible for managing requests about rights and will know how to apply the exemptions that are available to research, which are conditional on meeting further safeguards. Data Protection Officers also have to meet the new accountability requirements, which you may need
