If a plan does not comply with ERISA's audit requirements, the DOL may reject the plan's Form 5500. The plan sponsor then has 45 days to submit a satisfactory report to the DOL, including the required audit and financial statements. If the audit report is still not satisfactory, then the DOL has two options:

Form 5500: The Role Of The Accountant And The Audit Report

The limited-scope audit exemption is implemented by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The limited-scope exemption does not exempt the plan from the requirement to have an audit.

ERISA includes requirements for both retirement plans (for example, 401(k) plans) and welfare benefit plans (for example, group health plans).

The OCA "Augmented Workpaper Review Program" is the monitoring program utilized for firms that perform fewer than 100 annual ERISA audits. For this program, the OCA selects applicable CPA firms from its Form 5500 database, then it randomly selects one plan audit from each selected firm for review.
